Dormant Commerce Clause Marshall called the implied limitations of the Commerce Clause “dormant” leading to what we now call the Dormant Commerce Clause.

There are two main aspects to the modern Dormant Commerce Clause. First, states may pass evenhanded laws that impact interstate commerce, but even evenhanded laws may not impose undue burdens on interstate commerce.
