The result is a legal system which is actually shaped in Natural Law and Positive Law While natural law was “just and good antecedently to the command of God” (Turretin, Institutes, XI.i.4), divine positive law is just and good because of the command of God. All law cannot be positive law or else God would be free to command hatred of himself, which would be absurd. Natural Law and Divine Positive Law - Purely Presbyterian Natural law is the antithesis of positive law which is based on theories of majority rules, rights are granted and the government’s goal is to serve the

majority. In this form of government

the will of those in power is enforced and the minority is left unprotected, their rights at risk. The government becomes the arbitrator of right and wrong. Natural Law vs.
